## Why you have to make Home Insurance?

### ■ Full Protection

#### ● Building (excluding its foundation) which includes:

- Detached house, town house, roll house for residential purposes, garage and out buildings such as maid’s quarter, including retaining wall, fence, gate and improvement.

- Contents which include furniture, fixtures and fittings, tools, utensils, electrical appliances and equipments, musical instruments, audio sets, kitchenware, clothes, and the other household items.

### ■ Standard coverage

- Loss of personal money incurred as a result of burglary with visible marks and robbery or gang robbery at insured private dwelling house.
- Loss or damage to home contents during temporary removal
- Loss or damage to electrical appliances or installation from fire and lightning caused by overrunning, excessive-pressure, short circuiting, for instance.
- Loss or damage to the insured private dwelling house and contents by burglary with visible marks.

### ■ Personal Liability

It covers the legal liability of the insured of family members causing damages to the third party in respect of:

- Third party bodily injury or death by an accident
- Third party property damage by an accident
